## SIGNITURE REQUIRED ON BACK

**(Person reserving the party must call Thursday before the scheduled party with a final count of party guests.**

In order to secure your reservation, Hot Shots Indoor Sports Arena must receive the non-refundable deposit, upon reservation. This rental agreement is due to Hot Shots Indoor Sports Arena immediately following your receipt of the agreement. Your reservation is not guaranteed until Hot Shots Indoor Sports Arena has received this agreement along with deposit. If the aforementioned form and payment is not received by the specified time period, Hot Shots Indoor Sports Arena reserves the right to cancel this agreement, and retain the non-refundable deposit.

Renter takes full responsibility for the actions of all his/her guests. Renter agrees that any damage caused to Hot Shots Indoor Sports Arena during the due course of their rental at Hot Shots Indoor Sports Arena will be the rental party's financial responsibility. Renter agrees to pay all costs, including reasonable attorney's fees, incurred by Hot Shots Indoor Sports Arena in collecting rent or otherwise enforcing this agreement.

Proviso:

I, the undersigned, acknowledge and agree that attending or participating in sports may be hazardous and may result in injury. I further agree that I assume all risks of injury for myself and anyone who comes with me to the premises incurred or suffered while upon the premises or as a result of using the facilities or equipment therein.

I further expressly agree to release Hot Shots Indoor Sports Arena, its owners, employees, agents, successors, assigns, affiliates and anyone else associated with Hot Shots Indoor Sports Arena from any and all claims, demands or damages whatsoever, whether developed or undeveloped, known or unknown, anticipated or unanticipated, have, now or in the future, including, but not limited to any and all claims, demands or damages for negligence, personal injury and/or loss, theft or destruction of personal property. It is my intention that this release be as broad as Pennsylvania law allows releases of this sort to be. I understand that, without this document, the cost of participation would necessarily be greater, and I also acknowledge that I may obtain insurance to protect myself if I so choose.
